He obtained his Ph.D. at the Union Institute and University in 1995 and gained his "Reality Therapy Certification" from "The William Glasser Institute in 2004. Dr. Bellows has presented at many conferences and trainings and has published a multitude of articles.

Lynda Campbell - Currently volunteers at Angel Step Inn Emergency DV Shelter. Lynda was, formerly a staff member at Haven House, Inc. for 24 years, is an experienced counselo & group facilitator for male & female recovery programs, with emphasis on the impact of addiction on domestic violence.

He is a combat veteran who served in the U.S. Army Airborne with a tour in Vietnam as an infantry rifleman. Mr. Martinez has worked for the U.S. Department of Veteran Affairs, Readjustment Counseling Services Vet Center program since 1988; first as a Readjustment Counselor, and then as the Director of the U.S. Department of Veterans Affairs, East LA Vet Center where he provided clinical and administrative leadership for a community-based multidisciplinary team that provides combat veterans and their families with, Individual, Family and Group therapy. Mr. Martinez has been a certified Domestic Violence Counselor since 1999.Mr. Martinez was an Adjunct Professor at Citrus Community College, in Glendora, California, from 2007 to 2011; where he developed a unique first of its kind college curriculum entitled, "Boots to Books." Having earned national recognition, this course was designed for returning veterans to assist them with the successful college, employment, social, and home life reintegration. He recently retired after 35 years of federal service; and continues to be an active ABIP board member.
