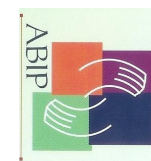

Tom Bellows, PhD - Dr. Bellows is a seasoned and experienced BIP facilitator with perpetrators since 1994. He obtained his Ph.D. at the Union Institute and University in 1995 and gained his “Reality Therapy Certification” from The William Glasser Institute” in 2004. Dr. Bellows has presented at many conferences and trainings and has published a multitude of articles.

Lynda Campbell - Currently volunteers at Angel Step Inn Emergency DV Shelter. Lynda, formerly a staff member at Haven House, Inc. for 24 years, is an experienced counselor & group facilitator for male & female recovery programs, with emphasis on the impact of addiction on domestic violence.

Michael Cochrane - Micheal either facilitates or co-facilitates DV groups at these agencies: Alternatives, LTD in Encino, Foothill Family Services, and The Valley Prevention & Treatment Center. He also has an expertise in intervention techniques for partner abuse, targeting self-esteem issues, anger, rage and family violence and overall relationship issues.

Dean Eddy has been working in the DV field for over twenty-five years. For nineteen of those years he was the Director of Client Services for the Abuse Prevention Program at the Southern Calif. Counseling Center and was facilitating at least three men’s groups and one women’s groups per week; working both with male and female offenders and survivors groups. Dean is a long time member of ABIIP and is currently on its board.

Isabella Goeders, MS is an MFT intern at the Chinatown Service Center in Los Angeles where she is a therapist working with families, parenting classes, and as a DV facilitator. She was one of the founding members of the Asian Pacific Islander DV Task Force in 2004. Isabella was one of the recipients of the 2013 Woman of the Year for years of volunteer and advocate work done with DV victims.

Alyce LaViolette MS, MFT - Founder of Alternatives to Violence in 1979; and has worked with battered women since 1978. Alyce is both a national and international speaker and trainer, an expert witness, and best-selling author for Safe Publications, with the 3rd edition of her book, “It Could Happen To Anyone; Why Women Stay.”

Maria Leyva has over 28yrs experience working in the DV field. She worked at Valley Family Center for 19yrs. as a director of the DV program. Maria presently works at the Jewish Family Services of LA as a residential counselor from ‘95 to the present and has worked in collaboration with the LA Juvenile, family & criminal courts, probation, parole, and DCFS depts. In 2011 Maria developed her new agency and is the executive director & founder of The Children Safety Alliance.

Albert Vidal - has been a domestic violence group facilitator for 23 years and is currently the DV Program Coordinator for Santa Anita Family Service for the last 8 years. Albert worked with high risk teens in the East Los Angeles area and as a chemical dependency and DUI counselor as well as being a former ABIP Co-Chair and ABIP board member at large.

Cecelia Walker - Is a seasoned professional with over five years’ experience, serving clients with profound social issues, through case management, group facilitation and community outreach. She is a volunteer and outreach activities coordinator with Angel Step Inn.

Cindy Tamayo obtained her Bachelor of Science in Human Services, with a track in Mental Health at California State University, Fullerton. During her undergrad her interest in working with domestic violence survivors grew when she got the opportunity to intern and later on obtain employment at an emergency domestic violence shelter.
